TERMS AND CONDITIONS 1 OCTOBER 2025 TO 31 DECEMBER 2025 HOMETEAMNS PROMOTION (THE "PROMOTION")

- 1. This promotion for free 1-year Group Personal Accident insurance (the "Free Insurance Policy") is valid with any application for free HomeTeamNS membership (the "Promotion") from 1 October 2025 to 31 December 2025 (both dates inclusive) (the "Promotion Period").
